P. Stradins Medical College of the University of Latvia is one of the largest medical colleges in Latvia, which provides students with a level 1 professional higher education in the fields of "Health Care" and "Social Welfare". Participation in ERASMUS + programme is a fundamental point in college strategy, internationalization and growth, promoting worldwide recognition in health and social care sectors, which in its turn leads to the development, modernization and updating of quality study process.

The main objective is to provide students and staff with an opportunity to gain academic and professional growth by participating in international mobility. The college implements nine study programs, with a total of about 1,000 students. Three of said programs are unique to Latvia, these being "Radiographer", "Podology" and "Biomedical laboratory technician". The above mentioned programs cannot be acquired at any other medical college. In supporting the desire for growth of students and lecturers, it is of paramount importance to provide them with the experience of foreign counterparts in transferring new innovations and learning methods. The possibility to undergo practice in leading clinics of the European Union countries means that students ought to be competitive both in labour market in Latvia, as well as other countries.

Mobility provides lecturers with international experience, discussions with foreign audiences facilitate interaction and exchange of views in the cross-cultural environment. The college lecturer's experience abroad means professional development and communication in a foreign language with colleagues in his/her sector.

Participation of staff in ERASMUS + mobility provides a mutual exchange of views and experience with colleagues, which will further encourage the use of experience-based techniques in their capacity. Alongside visits to partner establishment of higher education, visits to other sector-related institutions are provided.

Main tasks of participating in the ERASMUS + programme are - to increase the number of mobilities (students, lecturers, staff) going abroad and arriving to the country to ensure a wider transfer of knowledge and competences within the profession.

Lectures of foreign lecturers at the college provide non-mobility students with an opportunity to hear and discuss novelties within the profession, as well as to learn about experiences in other regions. By increasing the number of guest lecturers (from universities and businesses) we increase the numbers in target audience that learns this knowledge.

One of the objectives of internationalization policy of P. Stradins Medical College of the University of Latvia is to provide at least 5% of the total number of students with an opportunity to travel in mobility, and to increase the number of travelling teachers/staff each year. Currently on average 10 personnel/teacher mobility activities are financed from the ERASMUS + programme funds. The goal would be to provide at least 20 mobilities annually.

As part of the strategy, creation and development of new study programs based on labour market demand is planned. With support of the ERASMUS + programme we would identify new cooperation partners or new study programs provided by existing partners, to gain informative support and initiative.

The ERASMUS + programme is not just mobility, but also includes KA2 projects, that promote college involvement and active participation in innovation, experience and strategic partnership projects. Currently P. Stradins Medical College of the University of Latvia is a partner in two KA2 projects.

Participation in international projects is the cornerstone of internationalization, which promotes interaction between educational institutions and businesses in multiple countries. For P. Stradins Medical College of the University of Latvia, operating in health and social care sectors, continuous growth and pursuit of innovation is paramount to prepare its students for professional activity of high-quality.

P. Stradins Medical College of the University of Latvia has been an active participant in the activities of the ERASMUS + programme already since year 2006 – in providing mobility and lately also in KA2 activities.

Participation IN KA1 projects has amassed experience and proved successful in cooperation with existing partners in Latvia and abroad. Engagement of new partners is carried out, assessing their compliance with professional standards. "Incoming" and "outgoing" mobility is the responsibility of the international coordinator, who organizes all activities related to the ERASMUS + programme (advertising of competition, announcing of decisions, arranging and managing of documentation). Participation in KA1 activities will ensure mobility for students, teachers and staff.

Projects carried out within the framework of KA2 activities are managed by the responsible departments and study programmes. Transfer of innovation, strategic partnerships and experience projects ensure the modernization and digitalization of the study process. For example, one of the existing projects (Emed-PASS) is linked to the creation of a new platform in the Baltic States, whose aim is to identify the skills and competencies in provision of medical treatment for patients of students in the "Nursing" study programme. Project managers or contacts shall be appointed by the departments responsible for quality implementation of all project activities. The international coordinator shall monitor these activities and follow the measures for the dissemination of results.

Participation in KA2 projects promotes recognition of P. Stradins Medical College of the University of Latvia among medical education establishments in the programme countries and partner countries. This is fully in line with the college strategy and promotion of quality: innovative ideas, an improved and modernized working environment, an improved study process and advancement of recognition.

Participation in the ERASMUS + programme KA1 and KA2 activities will ensure recognition for P. Stradins Medical College of the University of Latvia amongst higher education establishments implementing study programmes in "Health Care" and "Social Welfare" sectors on an international level. During internationalization process, qualitative indicators will be evaluated – satisfaction of participants with the results achieved (surveys by questionnaire and success stories), reflections from persons involved (surveys and interviews), procedures for the circulation of documents (use of e-signature, speed of data circulation). These indicators will be applied to KA1 activity projects. Quantitative data: number of mobility participants (outgoing/incoming) is expected to increase by an average of 5% per annum. Risk factors include family status of students, knowledge of foreign tongue, motivation and lack of confidence.

During the mobility period, all participants receive support throughout the duration of said period, by submitting documents and drawing them up to the final stage. The international coordinator supports both outgoing and incoming mobility.

Engagement of new international partners is assessed on the basis of qualitative indicators: relevance of study programmes (studies/practices) to the ones realized at the college, motivation and interest in developing new partnerships; resources that provide the student with an environment to support him/her (student service, service hotel). Consequently, the potential participant is better informed about the expected results and the requirements and rules before the start of mobility. Active communication with the partner contributes to high-quality project management.

The new ERASMUS + programme stipulates strengthening and deepening of partnerships with existing partners through more KA2 activities. As part of the strategy, P. Stradins Medical College of the University of Latvia plans to head KA2 projects, instead of being just a partner. Potential sector: "Podology", which is currently in the process of development in the Baltic States. Participation in KA2 projects will contribute to the quality of college development -

improving the study process with innovative methods, digitalization, closer collaboration with representatives of the field in the labour market, as well as getting to know new partners within the programmes and partner countries.

Higher education institutions that provide the possibility of study within the medical sector are constantly developing, evolving and following innovation in order to provide the student with a high-quality, modern and growth-enhancing environment. In the next period, it is the introduction of innovation and new training methods that is the main objective of college development, taking into account the opportunities provided by the ERASMUS + programme.

#### 2. IMPLEMENTATION OF THE FUNDAMENTAL PRINCIPLES

#### 2.1 Implementation of the new principles

Please explain the measures taken in your institution to respect the principles of nondiscrimination, transparency and inclusion of students and staff. In order to ensure the principles of non-discrimination and equality are observed for students, staff and lecturers of the P. Stradins Medical College of the University of Latvia there is a "Procedure by which students apply for ERASMUS + mobility funding for studies/practice abroad, the selection arrangements and academic recognition of study/practice acquired", as well as "Procedure by which academic and general staff apply for Erasmus + programmes for mobility funding abroad, the selection arrangements and academic recognition". These documents provide for transparency in evaluating mobility for students and academic/general staff. When launching an ERASMUS + mobility competition, each study group individually is presented with rules, opportunities to apply for internships/studies abroad. During the evaluation process, the commission signs a document stating compliance with the rules of conflict of interest. Academic/general staff of the college is individually addressed and motivated to go for exchange of experience. Information regarding application period is stated publicly – on the college website www.psk.lu.lv as well as the college Facebook account.

P. Stradins Medical College of the University of Latvia is one of the higher education institutions implementing programmes in which studies can be acquired by people with disabilities, for example, in the field of social welfare studies. College educates students with both impaired vision and hearing. During the current period of the ERASMUS + programme, the student with disability realized a very successful practice mobility in Italy. Any and all students, in accordance to the criteria laid down, can apply as a candidate for the ERASMUS + programme to achieve the possibility of practice/studies abroad.

The college has a branch in Rēzekne, which implements 3 study programmes, covering Latgale region. Students are regularly informed and motivated to participate in mobility activities.

To reach a larger target audience, an ERASMUS + seminar is organized annually. During this, students returning from their mobility practice share their views and impressions on what they have experienced. This is an opportunity to reach out to the people in the audience who still think about applying.

Results of the approved mobility are sent to the participant electronically, according to contact details provided by the participant. From then on individual work with the international coordinator is ongoing.

Please explain what measures your institution will put in place to implement the European Student Card Initiative, and promote the use of the programme's Erasmus+ mobile App to students. Please refer to the timeline indicated on the European Student Card Initiative website<sup>2</sup>.

P. Stradins Medical College of the University of Latvia currently provides students with ISIC (International Student Identity Card), which includes international recognition. The next period will highlight the importance of the European Student Card, informing students about its possibilities and meaning. For participants of the ERASMUS + programme, the card will be stated as the preferred form of identification. Introduction of the card in college is linked and dependent on the approval and implementation of regulations in the Latvian higher education system.

By perfecting the digital process and already engaging in ERASMUS Without Papers, mobility participants in ERASMUS + mobile App will be one of the tools for the circulation of documents and communication throughout the mobility period. The map and app information will be distributed to all college students through course emails, college webpage, Facebook account, as well as flyers and posters. For ERASMUS + mobility participants, the exigency for use of said means will be included in the contract. Use of App will be taught in collaboration with the international coordinator.

Please explain how your institutions will implement and promote environmentally friendly practices in the context of the Erasmus+ programme.

P. Stradins Medical College of the University of Latvia implements studies in two directions – "Health Care" and "Social Welfare", where incoming and outgoing mobility is made up of future and existing health care and social care professionals. Practice is organized in health and social care institutions that highly value environment and its accessibility. The internal environment of the college is designed to make students feel comfortable moving around the area, to make it easily accessible. Support for people with disabilities: adapted spaces, taught communication techniques. For example, during study process people with impaired vision have the possibility to attend college in the company of a seeing-eye dog; people with hearing disabilities have access to a mobile acoustic loop. Support for students of the "Radiographer"s" study programme – provision of dosimeters during studies. Each study programme has the necessary support to make the student feel comfortable and safe in the college environment.

During the process of internationalization, mobility participants are advised to use mobile applications for completing different purchases, acquisition and presentation of tickets. For example, a college might be in a geographic location, where it is more convenient to travel by train, purchasing tickets electronically. Foreign students use bikes to move from their dwellings to the place of practice. In evaluating and organizing potential place of practice for foreign students, the closest and most suitable place is chosen.

If necessary, study process is organized remotely, using different platforms, such as "MS Team", "Zoom", as well as the Moodle system. The library provides for the EBSCO database, where all students and staff have free access to scientific publications.

Mutual agreements are gradually being transformed and signed using e-signature. Master documents are signed, scanned, sent, and stored in the database. The It is stipulated that the Communications department of the P. Stradins Medical College of the University of Latvia will move to paperless document circulation within a one-year period.

Modernization, improvement and digitalization of the system for the circulation of documents within the college provides for an environmentally friendly and supportive attitude.

Please explain how you will promote civic engagement and active citizenship amongst your outgoing and incoming students before, after and during mobility.

P. Stradins Medical College of the University of Latvia is actively following the well-being of its incoming and outgoing students both in Latvia and beyond.

Outgoing students are introduced to the social functioning of the hosting partner school and possibilities to take part in different activities PRIOR to the mobility practice. Exchange of information with students of previous periods of mobility provides an understanding and motivation for the future student to engage in non-practice/study activities in the mobility country. It is recommended to participate in activities organized by the Erasmus Student Network in order to get to know new people, culture, traditions and environment. We discuss accommodation possibilities (service hotel or student-held apartment) with our partners. It is possible for College graduates, after ERASMUS + mobility, to return to their respective country of practice, for example, Germany, Spain, Italy, to pursue possibilities of employment or return to their family they have created there. These contacts are maintained and students are happy to support each other. It has been a very successful practice, when foreign students arriving in Latvia are teamed with college students taking part in ERASMUS + mobility in the next semester. They share the information, become friends/acquaintances who maintain communication initially in person, and afterwards on social networks. Next semester, when students of the P. Stradins Medical College of the University of Latvia go abroad, they already have support persons. Prior to start of the mobility, traditions and rules of behaviour, as well as peculiarities of communication of each country are discussed. The student learns the language of the host country to better integrate into the new circumstances.

During the whole period of PRACTICE, there is ongoing communication with both students and the coordinator of the receiving party. If at all necessary, for objective reasons, and the practice place provided is not in accordance with the conditions, it is changed.

FOLLOWING mobility, students share their experience, feelings, personal and professional benefits in a seminar with college students, who are potentially planning to participate in mobility. College lecturers and staff participate in the information chain to gain insight into student experience abroad. Students write their own success stories, which are published in the college webpage. Part of the students share their experience in health and social care institutions, working with new methods or techniques.

Incoming students are provided with an appropriate place of practice for the selected profession, with a mentor and support person PRIOR to beginning of the practice. If at all possible, we provide a place of residence in a college service hotel. If a foreign student expresses a desire to live separately in an apartment, we extend our support by providing all necessary information. A stay at the service hotel promotes communication and integration of foreign students with locals. When communicating with students before the beginning of mobility, we agree on what is necessary to ensure the quality of practice on their part and on ours.

During PRACTICE, student self-government of P. Stradins Medical College of the University of Latvia along with international coordinator, organizes an International evening, during which participants get know each other, present the country they represent and prepare traditional dishes. This promotes cross-cultural interaction. A joint trip to

different regions of Latvia is organized, so foreign students to get to experience not only the capital city, but also other cultural and beautiful places. Foreign students are enrolled in every activity organized by the college, as well as non-Erasmus Student Network, student groups with a united appeal, associations. In places of practice students participate in professional activities on a voluntary basis, for example, taking part in preparing materials and presentations on Gender Equality, the activities of Biomedical Laboratory technicains; training in the setting up and running of Cosmetology Offices; participating in surgical operations under the "Nursing" programme. To promote professional growth, students are included in the collective bodies of their respective places of practice. During practice, students, should they express such a wish at any given time, are offered Latvian language training. Students have the ability to communicate with international coordinator at any time, both on-site and through social networks. The main objective is to provide students with quality practices and an inclusive society.

AFTER mobility students receive certificates and an assessment of their activities. Currently there is a tendency for students to return as recent graduates and want to continue their professional activities in their former places of practice. Students choose Latvia as their future home country by finding job opportunities in the profession or in any other sector. Contacts are maintained to support and inform young ERASMUS + students if necessary.

All departments included in the Erasmus + of the P. Stradins Medical College of the University of Latvia fully recognized the period of student mobility abroad. It is indicated in the Supplement to the Diploma, in accordance with the regulations implemented by the college. Arrangements governing operation of the ERASMUS + programme in college require full recognition of this period for both student practice/student mobility and academic/general staff mobility.

Prior to mobility students reach an agreement on the expected number of credit points, proficiency and skills to be acquired in the mobility of practice/studies. Upon returning from it, the student must submit a practice assessment or a evaluation sheet that is equated for the corresponding study period.

Please describe your institution's measures to support, promote and recognise staff mobility:

Mobility of college academic/general staff is regularly supported and promoted by motivating employees to engage in and participate in ERASMUS + activities. The number of mobility applications is increasing every year, with more and more first-time applicants taking part in the process.

In cases where an application is submitted by a person who has participated in one of the activities during a previous period, first-time mobility is preferred. Each case is examined individually, on the basis of the application submitted. Staff are interested in participating in International weeks of partner higher education establishments, as they provide for development on many levels – both in terms of professional development (teaching, providing a technical base for materials, visits to places of practice, communication with representatives of the field from different countries) and in personal (improvement of foreign language skills, personal contacts).

Experience and information acquired is regularly presented at employee meetings, professional societies and associations, conferences, seminars, as well as integrated into the study process. During annual evaluation period, mobility is identified as non-formal education, which enhances knowledge and skills.

Upon returning from mobility, participants assess the knowledge and experience acquired, as well as evaluate the possibility of integrating them into the college study process. For example, new technical equipment, training methods.

Information on ERASMUS + mobility is available in staff e-mails, college webpage, meetings, information slides in college rooms.

The terms for new applications are sent to students via electronic medium. Individual meetings are organized with each group, to motivate and explain the importance and opportunities of mobility provided by implementation of ERASMUS + abroad.

Annual meetings with recent ERASMUS + students returning from internships/studies abroad to present their experiences to students and staff are very welcome.

Posters and information reports on the newest activities of the ERASMUS + programme are placed in the premises of the college and its branch offices.

As for other activities related to KA2 projects, specific departments and heads of study programmes are addressed. When assessing the urgency, necessity and relevance of the project to the college, a supporting or dismissing response is decided upon. Circulation of information at the P. Stradins Medical College of the University of Latvia takes place both in person, as well as using online tools; sending the necessary documents via electronic medium.

Please describe how you will ensure that the principles of this Charter will be well communicated and applied by staff at all levels of the institution.

Principles of the Erasmus Charter will be published in the college website. The international coordinator will organize a workshop for employees to inform them about the principles of the Charter and their role in the day-to-day college activities. In the current period of the charter, employees of the P. Stradins Medical College of the University of Latvia have complied with the principles, being cooperative and forthcoming to all foreign guests of the college (both staff and students). Employees are creating an inclusive environment to ensure the member of the ERASMUS + programme feels positive.
